

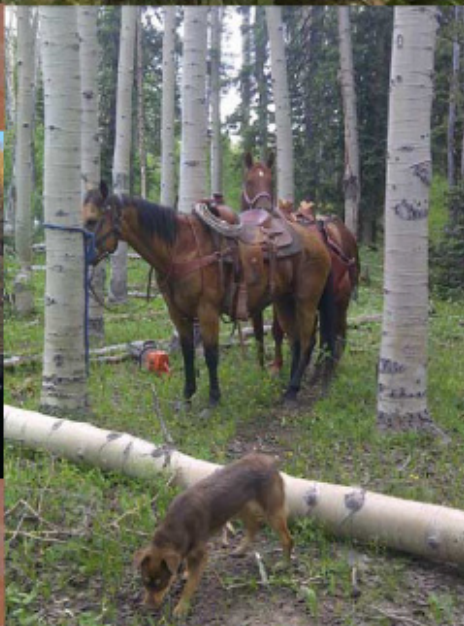

Working Ranch Adventure

June 20-24, 2013

Come ride with us. 600 cow calf pairs will arrive at base camp a few days before we arrive. Our job is to drive the cattle up the mountain to summer pastures, check fences, pack salt and other ranch tasks.

While working we will explore the wilderness of the San Juan National Forest, help you improve your horsemanship and cattle handling skills, and learn first hand about ranching in a National Forest. Enjoy wildlife and breath-taking scenery and views.

This ride is unique because you are encouraged to bring your own horse. We recommend that you and your horse are comfortable riding several miles a day. Your horse should be shod.

BASE CAMP (8 miles East of Bayfield, CO)

Park your truck and trailer at base camp. Base camp features a kitchen tent, picnic tables, campfire ring, cowboy shower with hot water and restroom. Flowing water and a corral is available for the horses. You are welcome to stay in your trailer or a tent. Cots available upon request. We will ride out each day.

Breakfast will be served at camp each morning. Lunch will be packed, taken with us, and enjoyed on the mountain. Dinner will be cooked on the campfire and served homestyle.

SCHEDULE

Riders are welcome to arrive on Wednesday to get settled in. Please notify us of your arrival time. Sunday evening we will go to the Bar D Chuckwagon Supper Show. More details online!
